NEW FEATURES & ENHANCEMENTS

Avalara Integration – With this long-awaited enhancement, NexGen is now integrated with the Avalara tax engine to auto calculate taxes upon creation of invoices and credit memos. All Avalara taxes will be summarized at the line level with the specific details stored in the Avalara system. Additionally, address validations will occur automatically when customer job sites are created in NexGen or with a single click when created from Atom. Sage Intacct Integration – This update brings exciting news for the customers who are currently using Sage 300 and upgrading to Sage Intacct or considering migrating to the Sage Intacct from their current accounting package. This feature will appear on your Job Quotes to capture the Job/Project responsibilities of Equipment Rental/Crane Companies ('Company') vs your customer's (Customer) responsibilities. This responsibility matrix will then be printed on your Quote documents. Responsibility Matrix helps to identify and clarify the roles and responsibilities between the company and customer on various important items/tasks. The items/tasks are configurable and get copied over to the quotes by default and can be included or removed at the quote level.



ITI Integration Enhancement – For the customers who are using the FCC - ITI Integration can further benefit from the link to the ITI Learning Portal for easy access to the on-field employees and Branding options.
